**I..GENERAL COURTS MARTIAL.**—The commanding officer, the Engineer Center, United States Army, Fort Belvoir, Virginia, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22a(6), to convene general courts martial, *effective 1 October 1952.*

**II..GENERAL COURTS MARTIAL.**—1. *Effective 1 March 1952*, so much of paragraph 1, section I, DA General Orders 25, 1952, as reads "373d Major Port," is amended to read "373d Transportation Major Port."

2. *Effective 15 July 1952*, so much of section I, DA General Orders 70, 1952, as reads "7964th Headquarters Group, Base Section, European Command Communications Zone," is amended to read "Base Section, European Command Communications Zone."

3. *Effective 1 August 1952*, so much of section I, DA General Orders 85, 1952, as reads "7964th Headquarters Group, Base Section, United States Army Europe Communications Zone," is amended to read "Base Section, United States Army Europe Communications Zone."

**III..CAMP DRUM, WATERTOWN, NEW YORK.**—So much of section I, DA General Orders 105, 1951, as reads "Great Bend, New York," is amended to read "Watertown, New York."

**IV..FORT WAYNE, DETROIT, MICHIGAN.**—*Effective 1 November 1952*, Fort Wayne, Detroit, Michigan, is redesignated from a subpost of the Detroit Arsenal, a class II installation under the jurisdiction of the Chief of Ordnance, to a class I installation under the jurisdiction of the Commanding General, Fifth Army.

**V..HOLABIRD TRANSPORTATION CORPS RAILROAD REPAIR SHOP, FORT HOLABIRD, MARYLAND.**—*Effective 1 October 1952*, the Holabird Transportation Corps Railroad Repair Shop at Fort Holabird, Maryland, is redesignated the Holabird Transportation Corps Depot Maintenance Shop (Rail), a class II activity under the jurisdiction of the Chief of Transportation at Fort Holabird, Maryland, a class I installation under the jurisdiction of the Commanding General, Second Army.

**VI..OGDEN TRANSPORTATION CORPS RAILROAD REPAIR SHOP, OGDEN ARSENAL, UTAH.**—*Effective 1 October 1952*, the Ogden Transportation Corps Railroad Repair Shop at Ogden Arsenal, Utah, is redesignated the

Ogden Transportation Corps Maintenance Shop (Rail), a class II activity under the jurisdiction of the Chief of Transportation, at the Ogden Arsenal, Utah, a class II installation under the jurisdiction of the Chief of Ordnance.
