FORT KOBBE ARMY RESERVATION AND HOWARD AIR FORCE BASE, CANAL ZONE.—1. Pursuant to the agreement between the Commanding General, Caribbean Air Command, and the Commanding General, United States Army Caribbean, resulting from a letter from the Commander in Chief, Caribbean Command, to the Commanding General, United States Army Caribbean and Caribbean Air Command (file CC (F) 680), 7 September 1951, subject: Primary Jurisdiction of Fort Kobbe—Howard Air Force Base Reservation, and as contained in the subsequent second indorsement thereto from the Commander in Chief, Caribbean Command, to the Chief of Staff, Department of the Army, Washington 25, D. C. (file CC (F) 680), 3 October 1951, subject: Primary Jurisdiction of Fort Kobbe—Howard Air Force Base Reservation, the metes and bounds description of the boundary lines of the two separate parcels belonging to the Department of the Army and the Department of the Air Force within the perimeter boundary of the combined Fort Kobbe Army Reservation and Howard Air Force Base, as set forth in the Secretary of the Army Canal Zone Order No. 28, 11 August 1952, is announced.

a. Fort Kobbe Army Reservation, Canal Zone.—Beginning at monument E-0, which is a 12-inch square concrete monument, located on the westerly boundary of the Palo Soco Leper Colony, and at the southeast corner of Howard Air Force Base, the geodetic position of which, referred to the Canal Zone triangulation system, is in latitude $8^{\circ}54'$ N. plus 4,728.9 feet, and longitude $79^{\circ}34'$ W. plus 2,002.3 feet from Greenwich; thence with the boundary of the Fort Kobbe-Howard Air Force Base Reservation as established by Canal Zone Order No. 28 of the Secretary of the Army and being more particularly described in said order and shown on Panama Canal Company drawing No. 6116-46, to the centerline of the Venado River and an unmarked point "R"; said point being $S. 89^{\circ}53'30''$ W., 50 feet, more or less, from monument 1-A which is a 2-inch iron pipe more particularly described and located in Canal Zone Order No. 28. Point "R" also being the southerly southeast corner of Howard Air Force Base; thence northerly 1,000 feet, more or less, along the centerline of Rio Venado, to an unmarked point called "Q," located on parallel of latitude $8^{\circ}54'$ N. plus 1,300.0 feet; thence due east 3,100 feet, more or less, to an unmarked point called "F," located 20 feet southeasterly from the centerline of Foggin Road; thence northeasterly and northerly along the above-mentioned 20-foot offset line from centerline of Foggin Road, to an unmarked point called "O" located 30 feet from centerline on the northeasterly side of Andrews Boulevard, opposite its intersection with Foggin Road; thence northwesterly and northerly 2,850 feet, more or less, along a line parallel to and 30 feet northeasterly and easterly from the centerline of Andrews Boulevard, to an unmarked point called "N," located 20 feet southerly from the centerline of Evans Jones Street; thence easterly 2,500 feet, more or less, along a line parallel to and 20 feet southerly from the center lines of Evans Jones Street and Big Row Road, to an unmarked point called "M," located on meridian $79^{\circ}35'$ W. plus 1,600.0 feet; thence easterly 1,600 feet, more or less, to an unmarked point called "L," located on parallel of latitude $8^{\circ}54'$ N. plus 4,328.9 feet and meridian $79^{\circ}35'$ W. plus 0.0 feet; thence due north 400.0 feet to an unmarked point called "K"; thence due east 4,611.8 feet to monument E-0, the point of beginning.

The directions of the lines refer to the true meridian.

The area of the above-described tract is 1,622 acres, more or less (this area is computed from above the mean low water line), and is included in the total area shown on Panama Canal Company drawing No. 6116-46, entitled "Map Showing U. S. Army and Air Force Reservations, Fort Kobbe and Howard Air Force Base, Canal Zone," scale 1:10,000, dated April 25, 1952, on file in the Office of the Governor of the Canal Zone, Balboa Heights, Canal Zone.

b. Howard Air Base, Canal Zone.—Beginning at monument A. T. F. 2, which is a 2½-inch iron pipe set in concrete, located on the eastern boundary of the Arraijan Tank Farm Naval Reservation and on the right bank of the Rio Velasquez, the geodetic position of which, referred to the Canal Zone triangulation system, is in latitude 8°57' N. plus 2,611.3 feet and longitude 79°38' W. plus 2,100.1 feet from Greenwich; thence with the boundary of the Fort Kobbe-Howard Air Force Base Reservations as established by and more particularly described in Canal Zone Order No. 28 of the Secretary of the Army and as shown on Panama Canal Company drawing No. 6116-46 to monument E-9, said monument being more particularly located and described in Canal Zone Order No. 28, and being the northeast corner and the beginning point of the boundary of Fort Kobbe Army Reservation; thence due west 4,011.8 feet to an unmarked point called "K," located on the meridian 79°35' W. plus 0.0 feet; thence due south 400.0 feet to an unmarked point called "L"; thence westerly 1,600 feet, more or less, to an unmarked point called "M," located on the meridian 79°35' W. plus 1,600.0 feet and 20 feet southerly from the centerline of Big Row Road; thence westerly 2,500 feet, more or less, along a line parallel to and 20 feet southerly from the centerline of Big Row Road and Evans Jones Street, to an unmarked point called "N," located 30 feet easterly from the centerline of Andrews Boulevard; thence southerly and southeasterly 2,850 feet, more or less, along a line parallel to and 30 feet easterly and northeasterly from the center line of Andrews Boulevard, to an unmarked point called "O," located opposite Foggin Road, at an intersection with the northerly projection of the 20-foot offset line, along the easterly side of Foggin Road; thence southerly and southwesterly 1,000 feet, more or less, along the above-mentioned 20-foot offset line from the centerline of Foggin Road, to an unmarked point called "R," located on the parallel of latitude 8°54' N. plus 1,300.0 feet; thence due west 3,100 feet, more or less, to an unmarked point called "Q," located on the centerline of the Rio Venado; thence southerly 1,000 feet, more or less, along the centerline of the Rio Venado, to an unmarked point called "R," located N. 80°50'30" W., 50 feet, more or less, from a 2-inch iron pipe No. 1-A; said point "R" being in the boundary line of the Fort Kobbe-Howard Air Force Base Reservations as described in Canal Zone Order No. 28; thence continuing with the boundary of the Fort Kobbe-Howard Air Force Base Reservations as established by and more particularly described in Canal Zone Order No. 28, to the place of beginning of Howard Air Force Base Reservation at monument A. T. F. 2.

The directions of the lines refer to the true meridian.

The area of the above-described tract is 4,087.0 acres, more or less.

2. The conditions and limitations for the foregoing reservations are as contained in Canal Zone Order No. 28, 11 August 1952.
