VI_SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Specialist Ronnie J. Addington, , Company B, 2d Battalion 37th Armor, distinguished himself by heroism on 28 February 1966, near Burgfarrnbach, Germany. Specialist Addington was operating a ¼ ton truck enroute to his home kaserne when he came upon the scene of a traffic accident. A vehicle owned by a German National had left the road, overturned and burst into flames. The panic stricken driver could not free himself from the blazing wreckage. Specialist Addington halted his vehicle and rushed to aid the helpless driver. With complete disregard for his safety and ignoring the imminent danger of a gasoline explosion, he was successful in freeing the frightened, injured driver and removing him to a safe distance. Specialist Addington's quick action in the face of grave danger and his deep concern for his fellow

man are in the highest traditions of the United States Army and reflect great credit upon himself and the military service.

Private First Class Domingo Rios, United States Army, 76th Transportation Company, distinguished himself by heroism on the morning of 19 September 1966, near Hamburg, Germany. Private Rios was engaged in regular truck driving duties when he noticed a commercial truck loaded with high explosives afire on the side of the traffic dense autobahn. He immediately pulled his vehicle to the side of the road and pushed to render aid. The civilian driver in panic had abandoned his burning vehicle. There was no extinguisher in it. Without hesitation or concern for his own personal safety Private First Class Rios ran to his military vehicle, obtained a fire extinguisher and began to fight the fire. It was stubborn. The extinguisher was not sufficient to control the fire and was soon emptied. Ignoring the imminent danger of an explosion, he persevered. He again raced to his military vehicle, secured the remaining extinguisher and returned to fight the fire until he finally extinguished it. Through his quick presence of mind, ready courage, and deep concern for the welfare of others, he risked a hazardous action, and rapidly prevented an explosion that could possibly have caused loss of life including his own, and certainly extensive havoc property damage. Private First Class Rios' heroic conduct and prompt action in this emergency situation are in the highest tradition of the United States Army and reflect great credit upon himself and the military service. (This award supersedes the Army Commendation Medal awarded to Private First Class Domingo Rios, for heroism on 19 September 1966 as announced in General Orders No. 31, HQS USA Communications Zone, Europe, dated 13 February 1967.)

X_AIR MEDAL. 1. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal with "V" device for heroism while participating in aerial flight is awarded by the Department of the Army to:

, United States Air Force, distinguished Major Lenin S. Nicoloan, himself by heroic action on 11 September 1966, in the Republic of Vietnam. He was serving as aircrew member of a CV-2B (Caribou) aircraft which was participating in a hazardous emergency mission carrying reinforcements to the special forces camp at Ha Thanh. The camp had been under attack by the Viet Cong since the evening of 10 September and was in grave need of reinforcements. Major Nicoloan volunteered to fly the mission knowing full well that previous resupply missions flown that day had received intense ground fire with two aircraft receiving damage. The mission was completed at night under minimum weather conditions and in mountainous terrain. The landing had to be made with the aid of flareships, mortar flares, and smudge pots as improvised lighting. Enemy forces overlooking the airstrip directed intense automatic weapons fire on Major Nicoloan's aircraft during landing and take off. Major Nicoloan's bravery under the intense ground fire resulted in the successful completion of the mission and prevented the loss of this vital outpost to the enemy. Major Nicoloan's actions were in keeping with the highest traditions of the United States Air Force and reflect great credit upon himself and the military service.

2. By direction of the President, under the provisions of Executive Order 9185, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal 4th OLC w/"V" device for heroism while participating

in aerial flight is awarded by the Department of the Army to:

, United States Air Force, distin-Major Phillip E. Anderson, guished himself by heroic action while participating in aerial flight on 11 September 1966, in the Republic of Vietnam. Major Anderson was serving as a crewmember of a CV-2B Aircraft participating in a tactical emergency in a tactical emergency resupply mission to the special forces camp at Ha Thanh. The camp had been under attack by the Viet Cong since the evening of 10 September 1966, and was in desperate need of resupply. With full knowledge of the heavy automatic weapons and mortar fire around the camp, Major Anderson voluntarily flew two successful missions into Ha Thanh, carrying vitally needed ammunition. Major Anderson's bravery under the intense ground fire resulted in the successful completion of the mission and prevented the loss of this vital outpost to the enemy. The skill and courage displayed by Major Anderson under fire are in keeping with the highest traditions of the United States Air Force and reflect great credit upon himself and the military service.

XII_ARMY COMMENDATION MEDAL. By direction of the Secretary of the Army, under the provisions of paragraph 33, AR 672-5-1, the Army Commendation Medal with "V" device for heroism is awarded to:

Captain Paul E. Hammer, , United States Air Force, while acting in the capacity of forward air controller for the 1st Battalion, 35th Infantry, on 20 November 1966, received a call for immediate air support for a unit that had contacted the enemy. During the ensuing fire fight, Captain Hammer flew his aircraft over the battle area in order to mark the position accurately for the air support. Captain Hammer, disregarding his personal safety, stayed over the embattled unit until the air strike had been successfully completed. Captain Hammer repeated this action on the 24th and 28th of November 1966 with the same successful results. These actions of Captain Hammer greatly enhanced the successful accomplishment of the embattled unit's mission. His actions are in keeping with the highest traditions of the military service, and reflect great credit upon himself, his unit, and the United States Air Force.

Kanouce, , United States Air Force, distinguished himself by gallantry in action while engaged in military operations in Vietnam on 13 October 1966, and serving as the Forward Air Controller for the 5th Battalion, Airborne Division, Army of the Republic of Vietnam. The battalion, conducting a search and clear operation, suddenly was fired upon by a small hostile force and immediately deployed in direction of the fire. Captain Kanouce's subsequent courageous actions insured the success of the battalion's mission. After the battalion's being fired upon Captain Kanouce spotted a Viet Cong force of approximately two platoons on the north side of a river, not in the battalion's area of operation. Acting as a radio relay Captain Kanouce assisted the battalion in obtaining permission to enter the adjacent unit's area of operation. He and the senior advisor of the battalion directed field artillery and aerial rocket artillery into the hostile positions. In this general area a regimental size Viet Cong communications center was found. Flying dangerously low over the area, Captain Kanouce assisted the ground troops and the helicopter gunners by spotting Viet Cong hiding in the water along the river banks and in rice paddies near the river. Throughout this period with disregard for his own safety he exposed himself continuously to enemy fire. His keen observation of the battle area and astute assistance in use of supporting artillery and aerial rocket artillery were major contributing factors for 93 enemy KIA, 21 enemy captured, 30 weapons captured and 5 radio sets captured. During this operation, his brave action, personal example, and professional competence were of the highest order and reflected great credit upon himself and the military service.

Major Jesse M. Smith, , United States Air Force, distinguished himself by extraordinary achievement while participating in aerial flight as Forward Air Controller in the Republic of Vietnam on 19 February 1967. On that date Major Smith responded to an urgent request for assistance from Task Force I, Vietnamese Airborne Division, whose position was under attack by a North Vietnam Army reinforced by one additional infantry battalion and the normal regimental combat support. During the cited period Major Smith controlled a continual stream of high performance aircraft and systematically destroyed the attacking enemy. He directed these strikes so effectively that the NVA troops did not overrun the positions they assaulted and the two reinforcing battalions were blocked by the volume of ordnance from the air strikes. The body count left on the ground was over 340 dead left on the battle-

field and 150 weapons were captured. Major *Smith*'s actions on this day saved the lives of numerous friendly troops, and seriously crippled the enemy forces. The professional competence, aerial skill and devotion to duty displayed by Major *Smith* reflect great credit upon himself and the United States Air Force.

Captain William P. Stewart, , Forward Air Controller, Airborne Division Advisory Detachment, distinguished himself by extraordinary achievement while participating in aerial fight as Forward Air Controller in the Republic of Vietnam on 19 February 1967. On that date Captain Stewart responded to an urgent request for assistance from TF I, Vietnamese Airborne Division, whose position was under attack by a NVA Regiment reinforced by one additional infantry battalion and the normal regimental combat support. During the cited period Captain Stewart controlled a continual stream of high performance aircraft and systematically destroyed the attacking enemy. He directed them so effectively that the NVA troops broke contact and withdrew, carrying an estimated 100 dead with them. The body count on the ground was over 340 dead left on the battlefield, and 150 enemy weapons were captured. Captain Stewart's actions on this day saved the lives of numerous friendly troops, and seriously crippled the enemy forces. The professional competence, aerial skill, and devotion to duty displayed by Captain Stewart reflect great credit upon himself and the United States Air Force.
