ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 43D AIR DEFENSE ARTILLERY REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS)II

I-ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 20TH FIELD ARTILLERY REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS). 1. The 20th Field Artillery regiment will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the U.S. Army Regimental System, effective 16 March 1989. The 1st Bn, UIC: WAKJAA remains at Fort Hood, TX, and the 2d Bn, UIC: WC84AA remains in Germany.

2. The 2d Bn, 75th Field Artillery, UIC: WA1ZAA will be INACTIVATED in Germany under MTOE 6-445LE101, E10189, effective 16 March 1989. The 3d Bn, 20th Field Artillery, UIC: WA1ZAA will be ACTIVATED in Germany under MTOE 6-455LE101, E10189, with the following strengths: STSTR: 35 OFF, 2 WO, 558 ENL, 595 AGGAUSTR: 35 OFF, 2 WO, 531 ENL, 568 AGG, effective 16 March 1989.

II-ORGANIZATIONAL ACTIONS OF UNITS TO FORM THE 43D AIR DEFENSE ARTILLERY REGIMENT UNDER THE U.S. ARMY REGIMENTAL SYSTEM (USARS). 1. The 43d Air Defense Artillery regiment will be WITHDRAWN from the Combat Arms Regimental System and REORGANIZED under the U.S. Army Regimental System, effective 16 March 1989. The 1st Bn, UIC: WAWYAA and the 3d Bn, UIC: WHLJAA remain at Fort Bliss, TX; the 2d Bn, UIC: WAWZAA, the 6th Bn, UIC: WAWOAA, and the 8th Bn, UIC: WAVSAA remain in Germany.

2. The 4th Bn, 3d Air Defense Artillery, UIC: WAC2AA will be INACTIVATED in Germany under MTOE 44-635LE101, E10189, effective 16 March 1989. The 4th Bn, 43d Air Defense Artillery, UIC: WAC2AA will be ACTIVATED under MTOE 44-635LE101, E10189, with the following strengths: STSTR: 56 OFF, 15 WO, 681 ENL, 752 AGGAUSTR: 56 OFF, 15 WO, 656 ENL, 727 AGG, effective 16 March 1989.


